(Standard Operating Procedure 6A-1.04: “No two (2) officers or directors on the Board of Directors may simultaneously maintain his or her seat when: (a) Each is, or has a close familial relationship with, a director, trustee, officer, key employee of, or greater-than-10% owner in, the same business entity (or the investment entity related thereto) holding the Association membership; or (b) One is, or has a close familial relationship with a person, employed by the other either in a sole proprietorship maintaining an Association membership, or by a member organization in which the other individual is associated as a trustee, director, officer, key employee, or greater-than-35% ownership interest. Ownership interest in this section means voting power or profits in a partnership or limited liability company, membership interest in a nonprofit organization, or beneficial interest in a trust. “Close familial relationship” shall mean sibling, spouse, parent/child, or grandparent/grandchild.”)
