

Emerging Leaders Cohort Application

Purpose

ACA Emerging Leaders are individuals within the Accounts Receivable Management industry who have been hand selected by the ACA Leadership Development Committee as promising future leaders for the industry. The Cohort exists to build leaders by promoting growth and longevity of promising professionals who are still developing within the industry by providing resources, exposure, and networking opportunities.

The ACA Leadership Development Committee defines an Emerging Leader as someone with the following characteristics:

Commitment to Lead: Actively seeks opportunities to learn and grow as a leader.

Strong Initiative: Willing to take on a challenge and stay focused and disciplined.

Openness to Feedback: Embraces constructive criticism and coaching and uses it to improve.

Collaborative Spirit: Eager to learn from and contribute to the collective learning experience of the Cohort.

Leadership Goals: Possesses a clear idea of how they want to use their developing leadership skills in the future.

Industry Betterment: Dedicated to the betterment of their organization and the overall industry.

Emerging Leaders who are accepted to the Cohort by the Leadership Development Committee are accepted for a three (3) year term. After this initial 3-year-term, individuals who are otherwise eligible may reapply for the Emerging Leaders Cohort for a second and final 3-year-term.

Qualifications

- □ A natural person of 18 years or older.
- An individual ACA member or an employee of any ACA Company Member, including Affiliate, Attorney, Creditor or International.
- □ Hold a leadership role/position at your company or organization.
- □ Have not held an ACA Board of Directors position within the last 10 years.
- □ Have been a member of the Emerging Leaders Cohort for less than 6 years in total.
- Approval from your manager or supervisor to participate in the Emerging Leaders Cohort to meet the Expectations of Cohort Members listed below.

Expectations of Cohort Members

- Attend and participate in at least one (1) Emerging Leaders in-person event (these will be tied to Convention, Fall Forum, ACA's Spring meeting, and Washington Insights).
- □ Attend and participate in at least three (3) Emerging Leaders quarterly virtual meetings.
- □ Complete any assigned reading, exercises, or other tasks.
- Embrace the values of the Cohort through aligning your actions with the Leadership Development Committee's definition of an Emerging Leader (defined above under "Purpose").

Completing the Application

Remember the following:

- □ Complete the entire application.
- □ Sign your application, which acknowledges your review and understanding of ACA International's Code of Conduct (available at <u>www.acainternational.org/about/code-of-conduct</u>).
- Attach a professional reference (e.g.: manager, supervisor, client, vendor, or other industry member).

Instructions for completing application:

- 1. Complete all sections indicating Not Applicable (N/A) when necessary.
- 2. Please limit your responses to the word count allotted for each section.
- 3. Return your completed and signed application and professional reference to <u>corporate.secretary@acainternational.org</u>. An electronic signature is permitted by using the following format in the signature line: /John Smith/, or other electronic signature
- 4. If you have questions, please contact the ACA Corporate Secretary at corporate.secretary@acainternational.org.
- 5. The ACA Corporate Secretary must receive your completed application with a professional reference(s) attached within the deadline stated on the website for you to be considered for the current cohort (available at <u>www.acainternational.org/</u> <u>emerging-leaders</u>).
- 6. The Leadership Development Committee will review all applications and notify you of their decision. If you are not selected, the Committee will include a summary explanation of their decision and include steps to consider with a subsequent application.
